Subject: Petition of MSEDCL for Recovery of amount equivalent to local Body Tax paid /that would be paid to Aurangabad Municipal Corporation from the consumers situated within the geographical limits of Aurangabad Municipal Corporation
- Case No. 25 of 2013

Maharashtra State Electricity Distribution Company Limited has submitted a Petition under Section 62 of EA 2003, under affidavit before the Commission on 23/1/2013, Petition for Recovery of amount equivalent to local Body Tax paid /that would be paid to Aurangabad Municipal Corporation from the consumers situated within the geographical limits of Aurangabad Municipal Corporation. The following are the prayers of the Petitioner:-

- “ a) To admit the Petition.*
- b) *To give concurrence for recovery of LBT Charges by Respondent No 3 from the consumers situated within the geographical jurisdiction of Aurangabad Municipal Corporation at the rate of 11.5 paise per unit over a period of 8 months to compensate the payment of LBT made to Aurangabad Municipal Corporation for the period April 2012 to September 2012..*
- c) *To give further concurrence for recovery of LBT Charges by Respondent No 3 from the consumers situated within the geographical jurisdiction of Aurangabad Municipal Corporation for the period October 2012 onwards at the equivalent to LBT paid on per unit energy sold during the said month i.e. LBT in Rupees divided by Energy sold in KWH terms.*
- d) *To give concurrence for following similar principle in case any other Municipal Corporation / Council or any other Local self Government Body competent to levy LBT claims such LBT from the Petitioner, which would inter- alia mean the Petitioner, would recover from the consumers situated within the geographical jurisdiction of said Municipal Corporation /Council or otherwise Local self government Body an amount equivalent to LBT paid.*
- e) *To Permit the Petitioner to modify/ amend alter/ revise the Petition and to submit additional information /details ,as may be required during the proceedings;*

2. I am directed to communicate that the **Hearing** in the above matter will be held in the presence of the authorized consumer representatives on **Monday 15 April, 2013 at 15.00 hrs** in the office of the Commission at 13th floor, Centre No.1, World Trade Centre, Cuffe Parade, Mumbai 400 005

3. The Petitioner is directed to immediately serve a copy of its above mentioned Petition (both in soft and hard versions) to the Respondents and authorized consumer representatives.

4. The Respondents are directed to submit their say on affidavit, if any, on the above mentioned Petition with a copy to the Petitioner and the authorised consumer representatives well in advance.
