Subject: Petition for action under Section 55(3) & 142 of EA 2003, against (MSEDCL) for non-compliance of the Commission's Tariff Order and Regulations in regards to the Electricity Consumers.

- Case No. 40 of 2013

M/s. Flavex Aromats India Limited, has submitted a Petition, under affidavit on 19.03.2013, under Section 55(3) & 142 of EA, 2003

The following are the main prayer of the Petitioner -

“

- 1) *To penalise the concerned MSEDCL, the AE/EE for the various contraventions of tariff order & commission's orders referred in 3 & 8 of enclosure 1, under section 142 of electricity act 2003 (including the order in 33.(f) of case 2 of 2003 on 14-7-2005 by not refunding excess billing).*
- 2) *To pass interim order to direct the ombudsman suitably in our pending matter of review appeal 2 of 2013.*
- 3) *To order refund of Rs.22650 paid for the meter with interest under section 55.3 of EA 2003*
- 4) *To penalize the MSEDCL /its concerned officer for contravention of section 55.1 of electricity act 2003.*
- 5) *To order conciliation of accounts with all industrial customers on closure of every financial year and maintenance of CPL in updated form in conciliation with the customer.*
- 6) *To order MSEDCL to provide the split of the CRA, SAIII &SLC paid by petitioner at the time of obtaining connection.*
- 7) *To order review of 6.6 of MERC (CGRF&EO) regulation 2006to refund claims arising out of tariff order contravention from the limitation period.*

2. I am directed to communicate that the **Hearing** in the above matter will be held in the presence of the authorized consumer representatives on **Tuesday, 16 April, 2013 at 12.30 hrs** in the office of the Commission at 13th floor, Centre No.1, World Trade Centre, Cuffe Parade, Mumbai 400 005

3. The Petitioner is directed to immediately serve a copy of its above mentioned Petition (both in soft and hard versions) to the Respondent i.e. MSEDCL and four authorised consumer representatives before the scheduled date of hearing.

4. The Respondent is directed to submit its say on affidavit, if any, on the above mentioned Petition with a copy to the Petitioner and the authorised consumer representatives well in advance.
