Subject: Petition of M/s Nagreeka exports Ltd for not providing permission by MSEDCL for availing open access through Indian Energy Exchange (IEX).

1. *“ The MSEDCL should allow permission for availing partial Open Access for required power 3.25 MW through IEX as per the application submitted for our plant at Village Yavaluj, Tal-Panhale, Dist .Kolhapur -416205.*
2. *Compensation of Rs 25000/- towards cost of petition which includes MERC’s petition filling fee Rs. 5,000/-.*
3. *Initiate appropriate action against for non compliance of MERC’s regulations 2005 for open access against MSEDCL as per the provisions u/s 142 & 146 of Electricity Act, 2003”*
