Subject: Petition of MSEDCL in the matter of determination of Passing on the cost of Renewable Energy Purchase to the Industries responsible for Pollution and climate change in accordance with the Section 61, 62, 66,86 and 181 of Electricity Act 2003

**- Case No. 17 of 2013**

MSEDCL has submitted a Petition under affidavit on 12.02.2013, in the matter of Passing on the cost of Renewable Energy Purchase to the Industries responsible for pollution and climate change. The main prayers of the Petitioner are as under-

- “ 1. *To admit the petition in accordance with the Sections 61,62,66,86 and 181 of EA 2003, MERC (Terms and Conditions for determination of RE Tariff)Regulations, 2010 and MERC (Renewable Purchase Obligation, its compliance and REC framework Implementation)Regulations, 2010.*
2. *To segregate the RE power purchase from the ARR so that the overall tariff of MSEDCL gets reduced to that effect.*
3. *To approve a RE charges based on the cost of RE power purchase (as a pass through) to be payable by the Industry Consumers generating green house gases/ pollution.*
4. *To amount so collected to be deduced while determining the ARR of MSEDCL.*
