## **NOTICE**

Subject: Petition of Callus Biotech Pvt. Ltd. & Seema Biotech for non compliance of directions of CGRF Kolhapur in complaint Nos. 161&162 of 2012-13 by MSEDCL & For non compliance of the directions given by Hon'ble commission, & complaints for offences by companies & to add biotechnology (tissue culture) companies in load shading free category.

## - Case No. 45 of 2013

Callus Biotech Pvt. Ltd. & Seema Biotech, have submitted common Petition (as CGRF Kolhapur had held common hearing and given common order) with affidavit on 21.03.2013. for Non compliance of directions of CGRF Kolhapur by MSEDCL & for extending the applicability of ToD rebate beyond march 2013. He had rectified deficiency on 01.04.2013. The main prayers of the petitioners are as under-

- "1. The respondent be directed for the immediate compliance of the order of CGR Forum, Kolhapur Zone, Kolhapur dated 29<sup>th</sup> January, 2013 in complaint Nos. 161 &162 of 2013 and further be directed to refund the excess recovered amount immediately by cash or cheque to the petitioners along with interest 12% as ordered by CGRF.
  - 2. The respondent be punished for non- compliance of the directions of CGRF Kolhapur in spite of the order of CGRF, Kolhapur Zone, Kolhapur in favor of petitioners by way of penalty up to one lakh rupees for contravention of provisions of E. Act 2003 and regulations made there under, as provided in section 142 and /of the Electricity Act, 2003.
  - 3. Also the respondent be punished for offence as provided under section 149 of the Electricity Act 2003 as the commission may think fit.
  - 4. As per direction of Hon. Commission case 116 of 2008
    - "Consumers engaged in Hi-Tech Agriculture activity shall also be eligible for tariff applicable for agriculture pumping load."
    - It means all Hi-Tech Agriculture activity (tissue culture) gets subsidized agriculture Tariff (Tariff Code 09) of Agriculture pumping loads.
  - 5. According to IT policy 2003 Hon. Commission has considered IT as an industry. According to MSEDCL circular 46 Dated 14/01/2013 based on HON. Commission

Order, IT is 'load shading free' activity. Like wise, we hereby request Hon. Commission to add Biotechnology Industries in 'load shading free' sector.
