

**NOTICE**

Subject: Petition of Piaggio Vehicles Pvt. Ltd. For not providing permission by MSEDCL for availing open access through IEX.

- **Case No. 53 of 2013**

Piaggio Vehicles Pvt. Ltd have submitted a Petition under Section 2 (47), 142 ,146 of EA 2003 under affidavit on 16.04.2013, for seeking relief for not providing permission by MSEDCL for availing open access through IEX and for not adhering time limit to process application, required by law. Petitioner also alleged discrimination by MSEDCL and prays to take appropriate action against defaulting officers of MSEDCL for non compliance of MERC's Regulation 2005 for open access. The following are the main Prayers of Petitioner -

*“ 1.The MSEDCL should allow permission for availing partial Open Access for required power 3.0 MW through IEX with immediate effect as per the application submitted for our plant at Baramati.*

*2.Initiate appropriate action for non-compliance of MERC's regulations 2005 for open access against MSEDCL as per the provisions u/s 142 &146 of Electricity Act 2003*

3. I am directed to communicate that the **Hearing** in the above matter will be held on **Thursday, May 9, 2013. at 17.00 hours** in the office of the Commission at 13<sup>th</sup> floor, Centre No.1, World Trade Centre, Cuffe Parade, Mumbai 400 005
