2. Shri Mahendra J Tardeja (Prop. Prerana Stone Crusher) have submitted a Petition along with an affidavit on 26.04.2013 for Non compliance of Interim Order passed by CGRF & Interim Order passed by Hon'ble Electricity Ombudsman in representation No. 56/2013 passed on 17.04.2013. The main prayers of the Petitioner are as under-

*"a) Direct MSEDCL to comply with the interim directions given by Hon'ble Electricity Ombudsman with immediate effect.*

*b) Initiate Action against guilty officers of MSEDCL under section 142, section 146, & section 149 of EA 2003.*

*c) Direct MSEDCL to comply with their own circular of Internal reforms to carry out DTC wise energy audit & subsequent action thereof.*

*d) Issue suitable guidelines to management of MSEDCL to comply with the orders of Hon'ble CGRF or Ombudsman as the case may be*

*e) Applicant prays Hon'ble Commission to give any other direction to meet the justice in favour of applicant and in favour of all electricity consumers of state to meet the key preamble of electricity act 2003 i.e. protection of consumer interest.*
