

**NOTICE**

Subject: Petition of Maharashtra State Electricity Distribution Company Limited for Determination of Tariff by Bidding Process for Procurement of Power by Distribution Licensee (MSEDCL) in the matter of Wind (Renewable) Energy for FY2013-14 within Maharashtra.

- **Case No. 65 of 2013**

MSEDCL have submitted a Petition along with an affidavit on 07.05.2013 under Section 63 and 86(e) of the Electricity Act, 2003 for Determination of Tariff by Bidding Process for Procurement of Power by Distribution Licensee (MSEDCL) in the matter of Wind (Renewable) Energy for FY 2013-14 within Maharashtra.

2. The main prayers of the Petitioner are as under-

a) *Single Tariff Across State*

*Zone Wise Classification Approach should be discontinued and single PLF should be determined for entire state.*

b) *Competitive bidding for wind should be recognized and allowed*

*As wind power generation is approaching maturity (~17000MW installation), competitive bidding should be introduced.*

OR

b) *The petitioner MSEDCL may be permitted to procure wind power in FY 2013-14 by undertaking competitive bidding in a transparent manner in public interest and subsequently enter into the Long Term Energy Purchase Agreements with the successful bidders and*

*further MSEDCL may be permitted to take into account such purchase of renewable energy in MSEDCL RPO Target by granting suitable relaxation in Regulation No. 7.2 of MERC (Renewable Purchase Obligation, Its compliance and Implementation of REC Framework) Regulations, 2010*

c) *Ad-interim relief as may be deemed fit*

d) *The petitioner may be allowed to make additional submissions, if any.*

I am directed to communicate that the Hearing in the above matter will be held in the presence of authorised consumer representatives on **Wednesday, 29 May, 2013 at 11.00 hours** in the office of the Commission at 13<sup>th</sup> floor, Centre No.1, World Trade Centre, Cuffe Parade, Mumbai 400 005.

The Petitioner is directed to implead all Wind Power Producers Associations as parties in the matter and immediately serve a copy of its above mentioned Petition (both in hard and soft versions), along with its accompaniments, to the authorised consumer representatives and the interested stakeholders, whose addresses are given below.
