

**NOTICE**

Subject: Petition of M/s. SharadaShree Ispat Ltd for not providing permission by MSEDCL for availing open access through Indian Energy Exchange (IEX).

- **Case No. 66 of 2013**

M/s SharadaShree Ispat Ltd. have submitted a Petition under affidavit on 09.05.2013 under Section 2(47), 42(2, 3, 4), 142 & 146 of EA 2003 for seeking relief for not providing permission by MSEDCL for availing open access through IEX although there is provision of non-discriminatory open access under sub-section (47) of Section 2 read with sub-section (2) (3) and (4) of Section 42 of Electricity Act and regulations specified thereunder and for not adhering time limit to process application required by law. The Petitioner also alleged discrimination by MSEDCL and prays to take appropriate action against defaulting officers of MSEDCL for non compliance of MERC's Regulation 2005 for open access.

2. The main prayers of the Petitioner are as under-

- i) *The MSEDCL should allow permission for availing partial Open Access for required power 1.3 MW through IEX as per the application submitted for our plant at Plot No. E-12, MIDC, Butibori, Nagpur.*
- ii) *Compensation of Rs 25,000/- towards cost of petition which includes MERC's petition filing fee Rs 5,000/-*
- iii) *Initiate appropriate action for non-compliance of MERC's regulations 2005 for open access against MSEDCL as per the provisions u/s 142 & 146 of Electricity Act, 2003.*

3. I am directed to communicate that the **Hearing** in the above matter will be held in the presence of the authorized consumer representatives on **Wednesday 29 May, 2013 at 15.00 hrs** in the office of the Commission at 13<sup>th</sup> Floor, Centre No.1, World Trade Centre, Cuffe Parade, Mumbai 400 005.
