Subject: Petition of Western Coalfields Limited Elimination of 66 KV voltage level at Matardevi ,Sasti and Majri sub stations of Western Coalfields Limited, Nagpur and Order of MSEDCL for imposing penalty of electricity charges to be additionally paid as per Order of Hon'ble Commission.

- **Case No. 68 of 2013**

Western Coalfields Limited have submitted a Petition along with an affidavit on 16.04.2013 for Non compliance of Directions of Hon'ble MERC (Standards of Performance of Distribution Licensees, Period for Giving Supply and Determination of Compensation) Regulations, 2005 by MSEDCL and MSEDCL is degrading supply voltage line from 66KV to 33KV and for reconsideration of MERC Order No. MERC/Capaex/20092010/00238 dated 10.03.2010.

The main prayers of the Petitioner are as under-

- i) Admit the present petition and review its order MERC/Capex/2009-2010/00238 dt.10<sup>th</sup> March 2010.*
- ii) After conversion of three 66 KV supply points in WCL (WCL Matardevi 10.5 MVA Contract Demand, WCL Sasti -9 MVA Contract Demand, & Majri-6.9 MVA Contract Demand) into 33KV, the Contract Demand should remain intact & no penalty to be charged on recorded Maximum Demand within sanctioned Contract Demand.*
- iii) Pass a speaking Order after duly considering and taking into account the submissions of the Review Petitioner;*
- iv) Pass any other orders as this Hon,ble Commission may deem fit in the interest of justice.'*
