- **Case No. 70 of 2013**

M/s Tata Power Company Ltd has submitted a Petition along with an affidavit on 13.05.2013, for Review of MERC Order in case No.178 of 2011 dated 30.03.2013 in the matter of Tata Power -T true-up Petition for FY 2011-12 and the Multi Year Tariff Petition for the period FY2012-13 to FY2015-16. The main prayers of the Petitioner are as under-

*a) The Hon'ble Commission to kindly approve the depreciation for the periods FY2008 - 09, FY2009-10 and FY2010-11 on account of restoration of Capitalisation in the respective years for reasons as elaborated in the petition.*

*b) The Hon'ble Commission to kindly approve the depreciation for the period FY2011 -12, as submitted by Tata Power-T for the reasons as elaborated in the petition.*

*c) Appropriate directions from the Hon'ble Commission it deems fit."*
