
### NOTICE

**Subject: Suo-motu Hearing on Review of Quarterly Progress Report in Case No. 151 of 2011 submitted by TPC-D and RInfra-D.  
- Case No. 85 of 2013.**

The Commission had given certain directions to The Tata Power Company Limited (Distribution) in its Order dated August 22, 2012 in Case No. 151 of 2011 and had also directed TPC-D to submit Quarterly Reports regarding the progress of changeover and switchover in TPC-D's licence area. Similarly, RInfra-D was also directed to submit the Quarterly Reports.

2. The Commission is in receipt of the Quarterly Reports from TPC-D and RInfra-D for the first three Quarters, viz., Aug-Sep 2012, Oct-Dec 2012, and Jan-Mar 2013. The Commission has also obtained certain data regarding the status of network addition in the identified 11 Clusters. The Commission has analysed the progress of changeover and switchover and the status of creation of network in TPC-D's licence area and has observed that there are discrepancies between the submissions made by TPC-D and RInfra-D, and also that the progress of changeover and switchover consumers and the creation of network appears to be quite slow and needs to be taken up expeditiously.

3. The Commission is of the view that under the circumstances, it is necessary and expedient to hear the Tata Power Company Limited on any explanation that it desires to offer on the progress of changeover and switchover consumers and the creation of network in TPC-D licence area. Therefore, Tata Power Company Limited is directed to appear before the Commission on **Thursday, 11 July 2013 at 11.00 hours** in the office of the Commission at World Trade Centre, Centre 1, 13<sup>th</sup> Floor, Cuffe Parade, Mumbai 400 005. If the Tata Power Company Limited wishes to offer any explanation in writing, the same may be filed under an affidavit at least prior to the said date of hearing.
