Maharashtra Industrial Development Corporation have submitted a Petition along with an affidavit on 17.06.2013 under Section 61,62 & 86 of E.A. 2003 in the matter of MERC Tariff Regulations, 2011 and 2) Tariff Order dated 16.08.2012 in Case No.19 of 2012, seeking certain Clarification and for issuing certain directions to Respondent -MSEDCL

2. The main prayers of the Petitioner are as under-

“a)That this Hon’ble Commission may clarified that MIDC water works, effluent/sewage treatment plants and pumping station falls under the HT IV(PWW) category.

b) That this Hon’ble Commission direct the Respondent MSEDCL to apply the tariff in category HT IV to the Petitioner and the Respondent further directed to issue to the Petitioner all further bills for consumption of electricity as per HT IV Tariff category.

c) That this Hon’ble Commission direct the Respondent to revise all the bills for consumption of electricity issued to the Petitioner from june 2010 on the basis of category HT IV Tariff.

d) Such other further orders, as are deemed fit in the interest of justice be granted in favour of the Petitioner.”
