Subject: Clariant Chemicals (India) Ltd. Petition for not providing permission by MSEDCL for availing partial open access through IEX.

- **Case No. 98 of 2013**

Clariant Chemicals (India) Ltd. have submitted a Petition under affidavit on 13.08.2013, for seeking relief for not providing permission by MSEDCL for availing partial open access through IEX and for not adhering time limit to process application, required by law. Petitioner also alleged discrimination by MSEDCL.

The main prayers of the Petitioner are as under-

“ 1.The MSEDCL should allow permission for availing partial Open Access for required power 2.5 MW through IEX with immediate effect as per the application submitted for our plant at Roha”.
