Subject: Hitesh Mukundrai Dani Petition for non compliance of Order dated 08.04.2013, passed by the CGRF Bhandup Urban Zone, Bhandup.

- **Case No. 100 of 2013**

Hitesh Mukundrai Dani have filed complaint under affidavit before the Commission on 17 July, 2013, under Section 142, 146 of the Electricity Act, 2003, against MSEDCL for non compliance of Order dated 08/04/2013, passed by the CGRF Bhandup Urban Zone, Bhandup.

The main prayers of the Petitioner are as under-

- “ a) The Respondent may kindly be punished as per the provision of section 142, 146 of I.E. Act, 2013 and they may be sentenced to imprisonment for the period of three months, and be directed to pay the fine of Rs.1,00,000/- for non compliance of an order dated 8th April, 2013 passed by Hon'ble CGRF,*
- b) The Respondent may kindly be directed to pay fine of Rs.6,000/- per day after the passing of the order by this Hon'ble forum till they actually comply with the order dated 8th April, 2013 passed by Hon'ble CGRF,*
- c) For any other relief”.*

I am directed to communicate that the **Hearing** in the above matter will be held in the presence of the authorized consumer representatives on **Wednesday, 13 November, 2013 at 11.30 hrs** in the office of the Commission at 13th floor, Centre No.1, World Trade Centre, Cuffe Parade, Mumbai 400 005

3. The Petitioner is directed to immediately serve a copy of its above mentioned Petition (both in soft and hard versions) to the Respondent before the scheduled date of hearing.

4. The Respondent is directed to submit its say on affidavit, if any, on the above mentioned Petition with a copy to the Petitioner and the authorised consumer representatives well in advance.
