

NOTICE

Subject: Petition of Tata Power Company Limited for Review of MERC Order dated 28.06.2013 in Case No. 179 of 2011 in the matter of Tata Power-D true-up Petition for FY 2011-12 and the Multi Year Tariff Petition for the period FY 2012-13 to FY 2015-16.

- **Case No. 99 of 2013**

Tata Power Company Ltd. have submitted a Petition under affidavit on 13.08.2013 in the matter of Petition for Review of MERC Order dated 28.06.2013 in Case No. 179 of 2011 in the matter of Tata Power-D true-up Petition for FY 2011-12 and the Multi Year Tariff Petition for the period FY 2012-13 to FY 2015-16.

The main prayers of the Petitioner are as under-

“ a) To allow the past recovery considering the impact of ATE judgment to the extent of Rs 78.18 Crores and allow to recover the past recovery of Rs 1029.11 Crores instead of Rs 950.93 Crores.

b) To review the disallowance of employee expenses to the extent of Rs 3.61 Crores.

c) To consider the revised capitalization of Rs. 187.93. Crores for FY 2011-12 instead of Rs.183.33 Crores as considered for the ROE and interest computation. Further the Hon'ble Commission to permit capitalization to the extent of Rs. 3.93 Crores towards the capitalization in FY 2008-09.

d) To allow additional A & G Expense of Rs.0.45 crore in order to rectify the double adjustment for disallowance of DSM expenses and provision for doubtful debts.

e) To allow an additional Rs.0.43 crore to rectify the double adjustment for disallowance of CSR expenses.

f) To revise the existing ToD Rate differential.

g) To review the tariffs for certain categories for compliance with the national tariff policy, 2006.

h) Appropriate directions from the Hon'ble Commission it deems fit.

2. I am directed to communicate that the hearing in the above matter will be held in the presence of consumer representatives on **Thursday, 21 November, 2013 at 11.30 hrs** in the office of the Commission at 13th floor, Centre No.1, World Trade Centre, Cuffe Parade, Mumbai 400 005.
