

**NOTICE**

Subject: Petition of Global Softech Pvt. Limited for not providing permission by MSEDCL for availing open access through IEX.

- **Case No. 103 of 2013**

Global Softech Pvt.Ltd have submitted a Petition under affidavit on 27.08.2013, for seeking relief for not providing permission by MSEDCL for availing open access through IEX and for not adhering time limit to process application, required by law. Petitioner also alleged discrimination by MSEDCL.

The main prayers of the Petitioner are as under-

*“ 1.The MSEDCL should allow permission for availing partial Open Access for required power 1.0 MW through IEX as per the application submitted for our plant at Bhivandi.*

*2. Compensation of Rs.20,000/- towards cost of follow up/petition which includes MERC’s petition filing fee.*

*3. Initiate appropriate action for non-compliance of MERC’s regulations 2005 and section 42 of Electricity Act 2003 for open access against MSEDCL as per the provisions u/s 142 &146 of Electricity Act 2003.”*

2. I am directed to communicate that the hearing in the above matter will be held in the presence of consumer representatives on **Wednesday, 27 November, 2013 at 11.30 hrs** in the office of the Commission at 13<sup>th</sup> floor, Centre No.1, World Trade Centre, Cuffe Parade, Mumbai 400 005.

3. The Petitioner is directed to immediately serve a copy of its above mentioned Petition (both in soft and hard versions) to the Respondent before the scheduled date of hearing.

4. The Respondent is directed to submit its say on affidavit, if any, on the above mentioned Petition with a copy to the Petitioner and the authorised consumer representatives well in advance.
