- *e)* That the Hon'ble Commission be pleased to direct the Respondent to refund forthwith and/ or adjust the amount of Rs.21,82,011.88/- on account of Additional Electricity Charges other incidental charges collected from the Petitioner on the basis of the said Commercial Circular."
