

**NOTICE**

Subject: Petition of MSEDCL in the matter of Order dated 03.09.2013 passed by the Hon'ble MERC in Case No.121 of 2012 directing MPECSL to submit its assets register to MSEDCL.

- **Case No. 120 of 2013**

MSEDCL have submitted a Petition under affidavit on 23.09.2013, under Section 142 of Electricity Act 2003 in the matter of Order dated 03.09.2013 passed by the Hon'ble MERC in Case No.121 of 2012 directing Mula Pravara Electric Cooperative Society Ltd. to submit its assets register to MSEDCL.

2. The main prayers of the Petitioner are as under-

*“ In view of the above, the Petitioner herein most respectfully prays that this Hon'ble*

*Commission would be graciously be pleased to:*

- i. Direct the Respondent; MPECS to submit copy of its asset registers of electricity business as directed by this Hon'ble Commission vide its order dated 03.09.2013;*
- ii. punish the Respondent; MPECS for noncompliance of the directions of this Hon'ble Commission by way of penalty upto Rs. 1 lac for noncompliance and additional penalty of Rs.6,000 per day for continuing failure, as prescribed under Section 142 of the Electricity Act 2003. Also, the Respondent; MPECS be punished for noncompliance and / or offence as provided under Section 146 and 149 of the Electricity Act 2003 as this Hon'ble Commission may deem fit.*
- iii) Pass any such further or other order as this Hon'ble Commission may deem fit and proper in the facts and circumstances of the present case.”*

I am directed to communicate that the **Hearing** in the above matter will be held in the presence of the authorized consumer representatives on **Tuesday, 19 November, 2013 at 12.30 hrs** in the office of the Commission at 13<sup>th</sup> floor, Centre No.1, World Trade Centre, Cuffe Parade, Mumbai 400 005.

4. The Petitioner is directed to immediately serve a copy of its above mentioned Petition (both in soft and hard versions) to the Respondent before the scheduled date of hearing.

5. The Respondent is directed to submit its say on affidavit, if any, on the above mentioned Petition with a copy to the Petitioner and the authorised consumer representatives well in advance.
