Subject: Nagreeka Exports Limited for not providing permission by MSEDCL for availing open access through IEX.

- **Case No. 117 of 2013**

Nagreeka Exports Limited have submitted a Petition under Section 2(47), 42(2,3,4), of E.A. 2003 under affidavit on 19.09.2013, for seeking relief for not providing permission by MSEDCL for availing open access through IEX and for not adhering time limit to process application, required by law. Petitioner also alleged discrimination by MSEDCL.

2. The main prayers of the Petitioner are as under-

- “ 1. The MSEDCL should allow permission for availing partial Open Access for required power 3.25 MW through IEX as per the revalidation application submitted for our plant at Village-Yavaluj, Tal- Panhale, Dist.- Kolhapur- 416205.*
- 2. Compensation of Rs.25,000/- towards cost of follow up/petition which includes MERC's petition filing fee Rs.5,000/-.*
- 3. MSEDCL failed to abide Section 42 of Electricity Act 2003 for non- discriminatory open access.*
- 4. Initiate appropriate action against the respondent per the provisions u/s 142 &146 of Electricity Act, 2003 for non-compliance of section 42 of Electricity Act 2003 & MERC's regulations 2005 for open access against MSEDCL.”*

3. I am directed to communicate that the **Hearing** in the above matter will be held in the presence of the authorized consumer representatives on **Wednesday, 04 December, 2013 at 12.00 hrs** in the office of the Commission at 13<sup>th</sup> floor, Centre No.1, World Trade Centre, Cuffe Parade, Mumbai 400 005.

4. The Petitioner is directed to immediately serve a copy of its above mentioned Petition (both in soft and hard versions) to the Respondent before the scheduled date of hearing.

5. The Respondent is directed to submit its say on affidavit, if any, on the above mentioned Petition with a copy to the Petitioner and the authorised consumer representatives well in advance.
