Subject: JSW Energy Limited for petition under Section 61, 86(1) (b) and other applicable provisions of the Electricity Act, 2003.

- **Case No. 118 of 2013**

JSW Energy Limited have submitted a Petition under affidavit on 02.09.2013 under Section 61 & 86(1)(b) and other applicable provisions of the Electricity Act, 2003. [Sec.61- Tariff Regulations, Sec.86- Functions of State Commission] The Petitioner had rectified the deficiency by paying proper fee and by signing the original petition on 25.09.2013.

2. The main prayers of the Petitioner are as under-

“a) determine the additional tariff payable by the Respondent taking into account the Petitioner having to import coal at substantially higher price than the contracted base price of USD 35 per metric tonne as a result of various uncontrollable factors, including the promulgation of Indonesian Regulations;

b) direct the Respondent to pay the additional tariff determined pursuant to (a) above for the period commencing from the date of commercial operation of Unit 1 of The Ratnagiri Project;

c) pending final disposal of this petition, award an interim increase in tariff over and above the tariff payable by the Respondent pursuant to the PPAso as to lessen the financial burden being suffered by the Petitioner; and

d) pass such further orders or directions as this Hon’ble Commission may deem just and proper in the circumstances of the case.

3. I am directed to communicate that the **Hearing** in the above matter will be held in the presence of the authorized consumer representatives on **Thursday, 21 November, 2013 at 12.00 hrs** in the office of the Commission at 13th floor, Centre No.1, World Trade Centre, Cuffe Parade, Mumbai 400 005.

4. The Petitioner is directed to immediately serve a copy of its above mentioned Petition (both in soft and hard versions) to the Respondent before the scheduled date of hearing.

5. The Respondent is directed to submit its say on affidavit, if any, on the above mentioned Petition with a copy to the Petitioner and the authorised consumer representatives well in advance.
