

**NOTICE**

Subject: Jindal Poly Films Limited for not providing permission by MSEDCL for availing open access through IEX.

**- Case No. 129 of 2013**

Jindal Poly Films Limited have submitted a Petition under Section 2(47), 42(2,3,4), of E.A. 2003 under affidavit on 25.09.2013, for seeking relief for not providing permission by MSEDCL for availing open access through IEX and for not adhering time limit to process application, required by law.

2. The main prayers of the Petitioner are as under -

*“1. The MSEDCL should allow permission for availing partial Open Access for required power 3.00 MW through IEX as per the application dt. 16.09.2013 submitted for our plant at Village- Mundegaon, Tal- Igatpuri, Dist. Nashik.*

*2. In view of the various sections of elect act 2003 referred above, it is obligatory on the part of MSEDCL to issue permission for non- discriminatory open access to its consumer.*

*3. Initiate appropriate action for non-compliance of MERC's regulations 2005 and various sections of EA 2003 referred above for open access against MSEDCL as per the provisions u/s 142 &146 of Electricity Act, 2003.”*

3. I am directed to communicate that the **Hearing** in the above matter will be held in the presence of the authorized consumer representatives on **Wednesday, 11 December, 2013 at 12.00 hrs** in the office of the Commission at 13<sup>th</sup> floor, Centre No.1, World Trade Centre, Cuffe Parade, Mumbai 400 005.

4. The Petitioner is directed to immediately serve a copy of its above mentioned Petition (both in soft and hard versions) to the Respondent before the scheduled date of hearing.

5. The Respondent is directed to submit its say on affidavit, if any, on the above mentioned Petition with a copy to the Petitioner and the authorised consumer representatives well in advance.
