Jawahar Shetkari Sahakari Soot Girni Ltd. have submitted a Petition under affidavit on 03.10.2013, for seeking relief for not providing permission by MSEDCL for availing open access through IEX and for not adhering time limit to process application, required by law. Petitioner also alleged discrimination by MSEDCL.

2. The main prayers of the Petitioner are as under -

*"1.The MSEDCL should allow permission for availing partial Open Access for required power 2.5 MW through IEX as per the application dt.23.03.2013 submitted for our plant at Dhule.* 

2. In view of the various sections of Elect Act 2003 referred above, it is obligatory on the part of MSEDCL to issue permission for non- discriminatory open access to its consumer.

3. Initiate appropriate action for non-compliance of MERC's regulations 2005 and various sections of EA 2003 referred above for open access against MSEDCL as per the provisions u/s 142 &146 of Electricity Act, 2003."
