Subject: Petition of Maharashtra State Electricity Distribution Company Ltd. for Review of Order dated 21.08.2013 passed by MERC in Case No. 68 of 2012.

- **Case No. 150 of 2013**

MSEDCL have submitted a Petition under affidavit on 21.10.2013, under Regulation No. 85 of MERC (Conduct of Business) Regulations, 2004 for seeking Review of Order dated 21.08.2013 (Case No. 68 of 2012), passed in petition filed by Adani Power Maharashtra Limited under Section 86 (1) (f) of the Electricity Act, 2003 for adjudication of dispute and for return of performance guarantee pursuant to the termination of its Power Purchase Agreements (PPA) with MSEDCL on 16 February, 2011.

2. The following are the main prayers of the Petitioner:

(a) That the order dated 21st August 2013 passed by this Hon'ble Commission in Case No. 68 of 2012 be modified / reviewed;

(b) Pending the hearing and final disposal of this Review Petition the operation and implementation of the order dated 21st August 2013 to the extent to pay the tariff rate at Rs. 3.124 per Kwh be stayed.

(c) For interim and ad-interim reliefs in terms of prayer clause (b) above.

(d) For such further and other consequential and necessary reliefs, as in the nature and circumstances of the case may require."
