

**NOTICE**

Subject: M/s. Mundra Steel & Alloys Private Limited for Petition under section 142 of the Electricity Act 2003 for violating the Order of Hon'ble MERC dated 5th September 2013.

- **Case No. 137 of 2013**

M/s. Mundra Steel & Alloys Pvt. Ltd. have submitted a Petition under affidavit on 09.10.2013, under Section 142 of the Electricity Act, 2003, against MSEDCL for violating the Order of Hon'ble MERC dated 5<sup>th</sup> September 2013 (in Case No.95 of 2013).

The main prayers of the Petitioner are as under-

*“ a) that the Hon'ble Commission be please to direct the Respondent to give full effect to the tariff order as modified by the MERC vide order its dated 5<sup>th</sup> September 2013 and Additional Electricity Charges be calculated and levied only from the billing month of September 2013.*

*b) that the Hon'ble Commission be please to direct the Respondent not to levy Additional Electricity Charges-1 for the Billing Month of August 2013.*

*c) that the Hon'ble Commission be please to direct the Respondent not to levy Additional Electricity Charges-2 for the Billing Month of August 2013.*

*d) That the Hon'ble Commission be pleased to quash and set aside the said Commercial Circular of the Respondent bearing No.209 dated 7<sup>th</sup> September 2013.*

*e) That the Hon'ble Commission be pleased to direct the Respondent to refund forthwith and/ or adjust the amount of Rs.964133.33/- on account of Additional Electricity Charges other incidental charges collected from the Petitioner on the basis of the said Commercial Circular.”*

3. I am directed to communicate that the **Hearing** in the above matter will be held in the presence of the authorized consumer representatives on **Wednesday, 13 November, 2013 at 14.30 hrs** in the office of the Commission at 13<sup>th</sup> floor, Centre No.1, World Trade Centre, Cuffe Parade, Mumbai 400 005.

4. The Petitioner is directed to immediately serve a copy of its above mentioned Petition (both in soft and hard versions) to the Respondent and the authorised consumer representatives before the scheduled date of hearing.

5. The Respondent is directed to submit its say on affidavit, if any, on the above mentioned Petition with a copy to the Petitioner and the authorised consumer representatives well in advance.
