Subject: Petition of Shri Charbhuj Sales Corporation, complaint u/s. 142 read with sec.42 of the Electricity Act 2003.

- **Case No. 140 of 2013**

Shri Charbhuj Sales Corporation have submitted a Petition under Section 2 (47), 42 (3), 86 (c), 86(e), 142 of E.A. 2003 & Regulation No.3.1 of MERC (Distribution Open Access) Regulations, 2005 & Regulation No. 92 to 94 of MERC (Conduct of Business) Regulations, 2004 for seeking relief in the matter of effective date of open access permission, granted by Respondent No.1 (MSEDCL) to Respondent No.2 (M/s. Nyati Hotels & Resort Pvt. Ltd.).

2. The main prayers of the Petitioner are as under-

“ a) The Respondent No.1 be directed to rectify the open Access permission dated 23.08.2013 and make it effective from 22.04.2013 instead of 01.07.2013.

b) The Respondent No.1 be further directed to give effect of the revised O.A. permission with effect from 22.04.2013 and issue credit notes accordingly.

c) All other just and equitable reliefs be granted to the Petitioner for the effective adjudication of this case.”
