Subject: Petition of M/s Urjankur Shree Datta Power company Limited for dispute between a generating company and a distribution licensee and seeking clarification /modification of the final Order dated 23.08.2013 passed in Case No. 89 of 2012 from the Hon'ble Commission.

- **Case No. 141 of 2013**

M/S Urjankur Shree Datta Power Company Limited have submitted a Petition under affidavit on 11.09.2013 under Section 86(1)(f) of the Electricity Act,2003 & Regulation No 92 of MERC (Conduct of Business) Regulations, 2004 for seeking clarification / modification of the final Order dated 23.08.2013 passed in Case No. 89 of 2012 passed by Hon'ble Commission.

2. The main prayers of the Petitioner are as under-

*“a. Clarify/ modify the order dated 23.08.2013 so as to dispense with the requirement of MEDA to submit the report, on issuance of REC's to USDPCL as per clause 81 of final order dated 23.08.2013, since the said report relates to a period which is part of seprate proceedings pending before the Hon'ble CERC; and,*

*b. Pass such other and further order or orders as this Hon'ble Commission deems fit and proper under the facts and circumstances of the present case.”*
