Subject: Petition filed by Maharashtra Eastern Grid Power Transmission Company Limited (MEGPTCL) in the matter of approval of Business Plan for second control period from FY 2013-14 to FY 2015-16 (Case No. 128 of 2013)

Sir,

1. This has reference to your Petition filed on 23 September, 2013 regarding approval of Business Plan for second control period from FY 2013-14 to FY2015-16 in Case No. 128 of 2013, the subsequent reply to the data gaps raised before and during the Technical Validation Session (TVS) held on 31 October, 2013 and revised Petition filed on 11 November, 2013.
2. I am directed by the Commission to convey to you, the admission of your above said Petition under Regulation 51 of the MERC (Conduct of Business) Regulations, 2004 for further processing and conduct of Public Hearing.
3. MEGPTCL is directed to publish the approved Public Notice enclosed herewith u/s 64 (2) of the Electricity Act, 2003 as per the following guidelines latest by **27 November, 2013**. The template for Public Notice sets out the minimum information for publishing the notice for soliciting suggestions and objections from the public on the Petition for approval of Business Plan for second control period of FY 2013-14 to FY 2015-16. MEGPTCL is free to include additional information, as it may consider necessary.
4. The Public Notice shall be published in not less than two (2) News Papers in English and two (2) News Papers in Marathi, which have wide circulation in the State of Maharashtra as licensee being the part of Intra State Transmission System (InSTS) in accordance with Regulation 90 of the MERC (Conduct of Business) Regulations, 2004, on or before **27 November, 2013**.
5. MEGPTCL shall publish the executive summary of its Petition (both in English and Marathi version) and the Petition submitted to the Commission on its website besides publishing formats in MS Excel for easy download by interested stakeholders. MEGPTCL shall make available a hard copy of the Petition to interested stakeholders with the specified Annexures and CD of detailed Petition with all Annexures, on written request, at the rates specified in the approved Public Notice enclosed with this letter. MEGPTCL shall ensure that the copies of the Petition and Annexures are legible.

6. MEGPTCL shall make available copies of the executive summary of its Petition (both in English and Marathi version) at its offices specified in the approved Public Notice, free of cost to interested stakeholders.
7. All the above Petition documents shall be made available by MEGPTCL in the specified form at the specified offices, latest by 27 November, 2013.
8. The Petition to be made available to public shall include the following:
 - Main Petition including executive summary, specified formats and all Annexures attached to the main Petition.
 - Replies to queries of the Commission before and after TVS with relevant Annexures
9. On receipt of suggestions and objections from the public on Petition, MEGPTCL should expeditiously reply to suggestions and objections not later than 18 December, 2013, for all the suggestions and objections received till 17 December, 2013.
10. The Public Hearing on MEGPTCL's Petition for approval of Business Plan for second control period of FY 2013-14 to FY2015-16 in Case No. 128 of 2013, is to be held at **Maharashtra Electricity Regulatory Commission, Court Room, 13th Floor, Centre 1, World Trade Centre, Cuffe Parade, Colaba, Mumbai - 400 005 on 19 December, 2013 at 12:30 Hours.**
