Subject: Petition of Maharashtra Veej Grahak Sanghtana, punishment to MSEDCL for non-compliance of directions under Section 142 and 146 of the Electricity Act, 2003 for contravention of FAC regulations and Application of Excess FAC on all the Consumers in the State.

**Case No. 170 of 2013**

Maharashtra Veej Grahak Sanghtana have submitted a Petition under affidavit on 14.11.2013, against the MSEDCL, under Sections 142 and 146 of the Electricity Act, 2003 for contravention of FAC regulations and Application of Excess FAC on all the Consumers in the State.

2. The main prayers of the Petitioner are as under-

*“1) Penalize the Respondent MSEDCL under S. 142 and S. 146 of the Act and impose additional penalty for every day during which the contravention of the provisions of regulations and wrong FAC application continuous.*

*2) Direct MSEDCL to refund excess collected FAC amount of Rs.1,836 Crore during FY 2012-13 alongwith interest as per S.62(6) of the Act to the consumers immediately.*

*3) Simplify the FAC allowing mechanism by amending it as pleaded by us in this Petition with immediate effect.*

*4) Treat this Petition important and dispose it off on priority.*

*5) Permit to make further submissions, addition and alteration to this Petition as may be necessary from time to time.*

*6) Condone any error/omission and to give opportunity to rectify the same.*

*7) pass any such or other Orders as the Hon'ble Commission deems fit and proper in the interest of justice and in the circumstances of the case.*
