2. The main prayers of the Petitioner are as under-

"1) The MSETCL may be directed to comply the Order dated 03.09.2013 passed by the District Collector, Aurangabad allowing the compensation for the losses suffered by the High Tension Transmission works in the field of landowners and to deposit the amount of compensation within 15 days along with penal interest on the amount of compensation from the date of installation of transmission tower.

2) The MSETCL may be penalized along with appropriate directions by this Hon'ble Commission u/sec 142, 146 & 149 for noncompliance Order 03.09.2013 passed by the District Collector, Aurangabad allowing the compensation for the losses suffered by High Tension Transmission works in the field owned by them and to deposit the amount within 15 days.

3) The District Collector, Aurangabad may be directed to enhance the amount of compensation by awarding four times of market value of land.

4) The petitioners may be awarded amount of compensation of trees by considering the cost of sowing, growing and maintaining trees and by considering the potential income from trees.

5) The MSETCL may be directed to pay Rs. 30,000/- each petitioner towards cost of litigation and Rs.100000/- (Rupees One Lac) each petitioner towards mental harassment and inconvenience caused.

6) Any other directions in the interest of justice and in the interest of public at large.
