C) Pending hearing and final disposal of this revision petition, the effect, operation and implementation of order dated 03.09.2013 passed by this Hon'ble Collector Aurangabad in the proceeding No. 2013/ Grahashakha / DDV /KV-89 may kindly be stayed.

D) Pending hearing and final disposal of this revision petition, stay may kindly be granted to the effect, operation and implementation of the impugned order passed by this Hon'ble Collector.

E) Pending hearing and final disposal of this petition, no coercive action be taken against the petitioner on the basis of order dated 03.09.2013 issued by the Hon'ble Collector Aurangabad.

F) Ad interim relief in terms and prayer clause C.D. & E. may kindly be granted in favor of the petitioner.

G) Any other and further relief may kindly be granted in favor of the petitioner as per the facts and circumstance of the case may warrant."
