MSETCL have submitted a Petition under affidavit on 02.12.2013, for Revision under Rule 13 (2) of the Maharashtra Electricity Work of Licenses Rules 2012 read with Govt. of Maharashtra G.R.No.0210/pk.29/Urja 4 Dt.01.11.2010 against the order No.56 Dt.12.08.2013 passed by the Hon'ble Collector Aurangabad.

2. The main prayers of the Petitioner are as under-

"A) The present revision petition may kindly be allowed.

B) The order dated 03.09.2013 passed by the Collector A'bad in the proceeding No. 2013/ Grah / DDV /KV-88 be quashed and set-side.

C) Pending hearing and final disposal of this revision petition, the effect, operation and implementation of order dated 03.09.2013 passed by this Hon'ble Collector Aurangabad in the proceeding No. 2013/ Grah / DDV /KV-88 may kindly be stayed.

D) Pending hearing and final disposal of this revision petition, stay may kindly be granted to the effect, operation and implementation of the impugned order passed by this Hon'ble Collector.

E) Pending hearing and final disposal of this petition, no coercive action be taken against the petitioner on the basis of order dated 03.09.2013 issued by the Hon'ble Collector Aurangabad.

F) Ad interim relief in terms and prayer clause C.D. & E. may kindly be granted in favor of the petitioner.

G) Any other and further relief may kindly be granted in favor of the petitioner as per the facts and circumstance of the case may warrant."
