Subject: Petition of Cosmo Films Limited (SEZ Unit). Complaint against Licensee (MSEDCL) in the matter of illegal recovery of additional amount against the order dt. 03.09.2013 in case No. 28/2013, date 04.09.2013 in case No. 44/2013, date 05.09.2013 in case No. 95/2013 passed by Commissions. Action under Section 142 & 146 of Elect. Act 2003 proposed against MSEDCL for violation of MERC's orders.

- **Case No. 19 of 2014**

Cosmo Films Limited (SEZ Unit) have submitted a petition under affidavit on 03.01.2014, against Licensee (MSEDCL) under Sections 62 (6), 142 & 146 of Elect. Act 2003 for illegal recovery of additional amount & violation of MERC's Order dt. 03.09.2013 in Case No. 28/2013, Order dt. 04.09.2013 in case No. 44/2013, Order dt. 05.09.2013 in case No. 95/2013 passed by Commission.

The main prayers of the Petitioner are as under-

*"1. Refund of excess amount collected by MSEDCL: We appeal to issue directives to the respondent to refund excess amount illegally collected from us along with accrued interest thereon.*

*2. Action as per Section 142 and 146 of EA Act 2003: We appeal to initiate Punishment for contravention of Commissions orders for case nos. 38/2013, 44/2013 & 95/2013 which has resulted illegal recoveries from us in energy bills of Sept. 2013 onwards.*

*3. Compensation of Rs. 50,000/- towards cost incurred for filing petition, attending hearings, man-hr cost, traveling expenses etc.*

*4. We may be allowed to submit additional submission to this petition as may be required during the proceedings or at later date.*

*5. Pass such further and other orders, as the Commission may deem fit and proper keeping in view the facts and circumstances of the case."*
