

NOTICE

Subject: Petition of M/s. Global Energy Limited under Sections 86 (1) (f) and 86 (1)(k) of the Electricity Act, 2003 against breach for Energy Supply Agreement dated 31.03.2011.

- **Case No. 24 of 2014**

M/s. Global Energy Ltd. have submitted a petition under affidavit on 10.01.2014, under Sections 86(1)(f,k) of the Electricity Act, 2003 for breach for Energy Supply Agreement dated 31.03.2011.

The main prayers of the Petitioner are as under-

“(i) issue directions upon the Respondent No. 1 for specific performance of the EPA dated 31.03.2011 executed with the Petitioner;

(ii) restrain the Respondent No. 2/ MSEDCL from issuing any credit notes to the Respondent No. 1 under any other arrangement, other than the EPA dated 31.03.2011, for the energy generated by the said generator until the end of the term of the said EPA;

(iii) direct the Respondent No. 2 to deny issuance of No Objection Certificates(NOCs) to the Respondent No.1 under any other arrangement, other than the EPA dated 31.03.2011, for adjustment of the credit notes, so as to restrain the Respondent No. 1 from adjusting/ disposing off power directly with third party consumers;

(iv) issue ex-parte interim relief in terms of prayers (ii) and (iii) above; and

(v) Pass such other order(s) as the Hon’ble Commission may deem fit and proper in the facts and circumstances of the case.”

2. I am directed to communicate that the **hearing** in the above matter will be held in the presence of the authorized consumer representatives on **Thursday, 20 March, 2014 at 12.00 hrs** in the office of the Commission at 13th floor, Centre No.1, World Trade Centre, Cuffe Parade, Mumbai 400 005

3. The Petitioner is directed to immediately serve a copy of its above mentioned Petition (both in soft and hard versions) to the Respondent and the authorised consumer representatives before the scheduled date of hearing.

4. The Respondent is directed to submit its say on affidavit, if any, on the above mentioned Petition with a copy to the Petitioner and the authorised consumer representatives well in advance.
