Subject: Petition of M/s. Uttam Galva Steels Limited for Reimbursement of transmission charges levied by the Maharashtra State Electricity Transmission Company Ltd. acting / officiating as the State Load Dispatch Centre on the sale of power since January 2011 to May 2012 on the Petitioner.

- **Case No. 03 of 2014**

M/s. Uttam Galva Steels Ltd. have submitted a Petition under affidavit on 24.12.2013 for Reimbursement of transmission charges levied by the Maharashtra State Electricity Transmission Company Ltd. acting / officiating as the State Load Dispatch Centre on the sale of power since January 2011 to May 2012 on the Petitioner.

2. The main prayers of the Petitioner are as under -

“a) the Hon’ble Commission may be pleased to direct the Respondent No.1 to refund or the Respondent No.2 to reimburse the sum of Rs. 1,24,86,734.40/- (Rs. One Crore Twenty Four Lakhs Eighty Six Thousand Seven Hundred Thirty Four and Forty Paise only) which was recovered as Transmission charge from the Petitioner for the period January 2011 to June 2012 along with 12% of interest till the time of realization of amount;

b) the Hon’ble Commission may be pleased to restrain Respondent No.1 from levying such Transmission charge;

c) cost of the present Petition;

d) any other just and proper relief as the Hon,ble Commission may deem fit and proper in the facts and circumstances of this case.

3. I am directed to communicate that the **Hearing** in the above matter will be held in the presence of the authorized consumer representatives on **Wednesday, 12 March, 2014 at 11.30 hrs** in the office of the Commission at 13th floor, Centre No.1, World Trade Centre, Cuffe Parade, Mumbai 400 005.

4. The Petitioner is directed to immediately serve a copy of its above mentioned Petition (both in soft and hard versions) to the Respondent and the authorised consumer representatives before the scheduled date of hearing.

5. The Respondent is directed to submit its say on affidavit, if any, on the above mentioned Petition with a copy to the Petitioner and the authorised consumer representatives well in advance.
