Subject: Petition of Shri Ashok Pandharinath Shinde & Shri Sudam Devrao Shinde under section 67, 68, 142, 146 and 149 of the Electricity Act 2003 and Works of Licensees Rules 2012. The petition for non compliance of regulation while laying down transmission line and the petition challenging the order passed by the District Collector, Jalana being aggrieved by the non determination of amount of compensation under the Works of Licensees Rules 2012 and non compliance by MSETCL by not paying amount of compensation to the District Collector, Jalana and Revision of Order dt. 24.01.2013 passed by the District Collector Jalana.

- **Case No. 40 of 2014**

Ashok Pandharinath Shinde and Sudam Devrao Shinde have submitted a Petition under affidavit under Section 67, 68, 142, 146 and 149 of the Electricity Act, 2003 and of Maharashtra Works of Licensees Rules 2012 for non compliance of regulation while laying down transmission line and challenging and for Revision of Order dated 24.01.2013 passed by the District Collector Jalana.

The main prayers of the Petitioner are as under-

“A) That Order passed by District Collector Jalna dated 24.01.2013 may be quashed and set aside.

B) That, the quantum of compensation of Rs. 1000000/- (Rupees Ten Lacs only) may be awarded to each petitioner towards loss of land caused due to transmission tower.

C) That the MSETCL be directed and ordered to pay each petitioner damages towards mental harassment of Rs. 100000/- (Rupees One Lac only) and towards Legal Cost of Rs. 50,000/-- (Rupees Fifty thousands.)

D) The Petitioners may be allowed enhanced amount of crop compensation and also ancillary losses.

E) The MSETCL may be penalized under section 142, 146 and 149 of the Electricity Act, 2003 For noncompliance of the Provisions of the Electricity Act and the rules thereunder, for causing inconvenience to the petitioners and not carrying proper panchnamas.

F) That any other suitable order or relief be granted in favour of the petitioner.”

4. The Respondent is directed to submit its say on affidavit, if any, on the above mentioned Petition with a copy to the Petitioner and the authorised consumer representatives well in advance.
