## **NOTICE**

Subject: Petition of Shri Bandu Vyankatesh Joshi to take action against MSEDCL officer for knowingly not supplying copies of reply to the petitioner by RPAD and not obtaining acknowledgement, thereby violating the orders of the Baramati CGRF.

## - Case No. 18 of 2014

Bandu Vyankatesh Joshi have submitted a Petition under affidavit on 25.11.2013, under Section 142, 146 of the Electricity Act, 2003 & Regulation 6.13, 8.7 & 22 of MERC (CGRF & Electricity Ombudasman) Regulations, 2006 against shri. R. G. Kolap, Executive Engineer, MSEDCL & Mrs. Neeta R Shinde, Dy. Executive Engineer, MSEDCL for Knowingly not supplying copies of reply (of petition filed by the Petitioner against Respondents in CGRF, Baramati) to the petitioner by RPAD and not obtaining acknowledgement, thereby violating the orders of the Baramati CGRF.

2. The main prayers of the Petitioner are as under-

"It is prayed that penal actions against respondent nos. 1 and 2 may be taken as per sec. 22 of the said Viniyam 2006, and section 142 of the Electricity Act or legal action may be initiated against them.

- 1) In this behalf it is submitted that, the Maharashtra Electricity Regulatory Commission(Consumer Grievances Redressal Forum and the Electricity Ombudasman) Viniyam, 2006, and provisions made therin are still inforce and they are not repealed or set aside, so far knowledge of the petitioner goes.
- 2) The petitioner wants to rely on section 6.13 of the said Viniyam 2006. And it is submitted that this provision is not followed In this case by the respondent 1 and 2.
- 3) Further, the petitioner wants to rely on section no. 8.7 of the said Viniyam 2006. According to this section, the respondents are bound to follow directions of the Forum and MERC, but have not followed and obeyed.
- 4) They have not furnished copies of replies of shri. Kolap, to the petitioner and have not complied with directions of the Hon, Forum and the MERC.

Further attention is invited to the section 22 of the said Viniyam, 2006 and according to this provision; it may be treated that this is violation of the said Viniyam, 2006, may be taken or if it is not applicable, any other legal action may be initiated against them as per this section 22 of the Viniyam, 2006."
