Subject: Petition of Maharashtra Airport Development Company for directions under Section 23, 86 (1) (b) (k) of the Electricity Act, 2003 r/w Regulation 92 of MERC (Code of Business) Regulations, 2004 and Regulation 8.6.8 of MERC (General Conditions of Distribution License) Regulations, 2006.

- **Case No. 62 of 2014**

Maharashtra Airport Development Company has submitted a Petition under affidavit on 11.03.2014, under Sections 23, 86 (1) (b) (k) of the Electricity Act, 2003 & Regulation 92 of MERC (Code of Business) Regulations, 2004 Regulation 8.6.8 of MERC (General Conditions of Distribution License) Regulations, 2006 for seeking relief relating to the supply of power.

2. The main prayers of the Petitioner are as under:-

“ i) Suitable directions may be passed to secure the supply power to the consumers in the MIHAN area and to prevent a complete blackout in the MIHAN area;

ii) Pass any other/ further order(s) in the interest of justice.”

Main prayers in Application submitted on 13.03.2014-

“i) Fix early date of hearing and pass suitable directions to prevent complete blackout in the MIHAN area and to give relief to consumers of MIHAN area.

ii) Pass any other/ further order(s) in the interest of justice.”
