Subject: Petition of Maharashtra Airport Development Company for directions under Section 23, 86 (1) (b) (k) of the Electricity Act, 2003 r/w Regulation 92 of MERC (Code of Business) Regulations, 2004 and Regulation 8.6.8 of MERC (General Conditions of Distribution License) Regulations, 2006.

- **Case No. 62 of 2014**

2. The Petitioner has filed Addendum to the Original Petition on 9.4.2014 and , the Petitioner prays as under:

“ i) *Suitable directions may be passed to secure the supply power to the consumers in the MIHAN area and to prevent a complete blackout in the MIHAN area;*
