

**NOTICE**

Subject: Petition of M/s Wardha Power Company Limited, for Review Petition of Order dated 17.01.2014 in Case No. 91 of 2013, under Section 94(1) (f) of the Elect. Act 2003.

- **Case No. 61 of 2014**

Wardha Power Company Limited has submitted a Petition under affidavit on 24.02.2014, under Sections 94(1)(f) of E.A. 2003 for seeking Review of Order dated 17.01.2014 in Case No. 91 of 2013.

2. The main prayers of the Petitioner are as under:-

*“a) Admit the present review petition;*

*b) Review and set aside the order dated 17.01.2014 passed by the Hon’ble Commission;*

*c) Hold and declare that the power procurement by R-Infra from VIPL is not to be approved in view of the tariff indicated being higher when electricity is available from the Petitioner at a cheaper cost;*

*d) Require Wardha Power to supply power at the reduced tariff than that of VIPL for the interim period of six months, subject to the condition that the supply shall be continued on comparison of the tariff being cheaper than that of VIPL determined on actual basis;*

*e) Pass such other further order(s) as the Hon’ble Commission may deem just in the facts of the present case.”*

3. I am directed to communicate that the admissibility hearing in the above matter will be held in the presence of consumer representatives on **Thursday, 15 May, 2014 at 12.00 hrs** in the office of the Commission at 13<sup>th</sup> floor, Centre No.1, World Trade Centre, Cuffe Parade, Mumbai 400 005.

4. The Petitioner is directed to immediately serve a copy of its above mentioned Petition, along with its accompaniments, (both in soft and hard versions) to the Respondent and the four authorized consumer representatives.

5. The Respondent is directed to submit its say, if any, on affidavit, on the above mentioned Petition with a copy served to the Petitioner and the consumer representatives.
