Subject: Petition of Sinnar Power Transmission Company Limited for approval of the Hon'ble Commission for creating encumbrance on the assets of licensed business of Sinnar Power Transmission Company Ltd.(SPTCL) under the provisions of section 15.3 of MERC (Transmission License Conditions) Regulations, 2004 as amended in 2006("Transmission License Conditions Regulations").

- **Case No. 70 of 2014**

Sinnar Power Transmission Company Limited has submitted a Petition under affidavit on 07.03.2014 under Regulation 15.3 of MERC (Transmission License Conditions) Regulations, 2004 as amended in 2006, for approval of the Hon'ble Commission for creating encumbrance on the assets of licensed business of Sinnar Power Transmission Company Limited for following transmission system:- 1) 400kV D/C Quad Moose Transmission Line from Sinnar TPP to existing MSETCL Babhaleshwar Sub - Station. 2) 2 Nos. 400 kV line bays at existing MSETCL Babhaleshwar Sub - Station.

2. The main prayers of the Petitioner are as under -

*" a) Provide approval for creation of charge over the assets of the applicant in favour of existing and all future lenders on an urgent basis to secure the financial assistance from lenders;*

*b) Condone the delay / any inadvertent omission / errors / shortcomings and permit SPTCL to add/ change/ modify/ alter/ this filing and make further submissions as may be required at a future date; and*

*c) Pass such other and further orders as are deemed fit and proper in the facts and circumstances of the case."*
