Subject: Petition of MSEDCL for Review of the Order dated 05.02.2014, passed by Hon'ble Commission in Case No. 83 of 2012.

**- Case No. 68 of 2014**

MSEDCL has submitted a Petition under Section 86(1)(f) & Section 94 of the Electricity Act, 2003, for Review of the Order dated 05.02.2014, in Case No. 83 of 2012 passed by Hon'ble Commission.

The main prayers of the Petitioner are as under-

*"a) This Hon'ble Commission be pleased to call for the records and proceedings relating to the order dated 05.02.2014 passed by this Hon'ble Commission in Case No. 83 of 2012, and after going through the legality and propriety therefore be pleased to review and modify the same, to the extent of the finding given by the Commission in respect of suppression and misrepresentation by the Petitioner, the fundamental error that mere mention of the order dated 24.05.2010 in Case No. 62 of 2009 will obviate the power of MSEDCL to enter into Franchisee for Single Point Supply, various findings on merit on the disputes and selective reliance on the decision of the Appellate Tribunal in Appeal No. 105 of 2007.*

*b) That this Hon'ble Commission be pleased to expeditiously hear the above matter.*

*c) For such further and other consequential reliefs, as in the nature and circumstances of the case may require."*
