Subject: Petition of Wat-ere-source Technologies P Limited for Providing power evacuation arrangement Karwand SHP in Dist. Dhule.

- Case No. 73 of 2014

Wat-ere-source Technologies P Limited has submitted a Petition under affidavit on 18.03.2014, under Section 86(1) of the Electricity Act, 2003, MERC Order RE Tariff, 2010 (Clause 1.7 Page 13/90), MERC RPO Regulations, 2010 (Clause 17.1 Page 9/10) and Government of Maharashtra Water Resource Department (GOMWRD) Policy dated 15.09.2005 for seeking relief relating to providing of power evacuation arrangement Karwand SHP in Dist. Dhule and providing Grid Connectivity and signing of EPA.

The main prayers of the Petitioner are as under-

“a) Although Honorable Commission has time to time has ruled expressly and implicitly that the cost beyond the interconnection point shall be borne by the licensee and shall be received from the consumers as per suitable pricing framework developed by the State Commission. Therefore, MSEDCL/MSETCL may please be directed to abide by the provisions of the MERC orders.

b) MSEDCL/MSETCL should provide the power evacuation arrangement as per technical approvals issued by competent authorities.

c) SHP projects are governed by GOMWRD policy dated 15.09.2005. MSEDCL/MSETCL should provide their facilities and services as per GOMWRD policy and MERC orders from time to time.

d) MERC may please seek public comments on draft of EPA and standardize it for all projects.

Honorable commission is requested to reconsider the above matters and issue specific orders, which will help promote SHP in the state.”

2. I am directed to communicate that the **Hearing** in the above matter will be held in the presence of the authorized consumer representatives on **Tuesday, 27 May, 2014 at 11.30 hrs** in the office of the Commission at 13th floor, Centre No.1, World Trade Centre, Cuffe Parade, Mumbai - 400 005.

3. The Petitioner is directed to immediately serve a copy of its above mentioned Petition (both in soft and hard versions) to the Respondents and the authorised consumer representatives before the scheduled date of hearing.

4. The Respondents are to submit its say on affidavit, if any, on the above mentioned Petition with a copy to the Petitioner and the authorised consumer representatives well in advance.
