Subject: Petition of Maharashtra State Electricity Transmission Co. Ltd., in regard to Review of Order in Case No. 39 of 2013 dated 13.02.2014 in the matter of Truing up of FY 2011-12, Annual Performance Review of FY 2012-13 and Aggregate Revenue Requirement for the MYT Second Control Period from FY 2013-14 to FY 2015-16.

f. The Hon’ble Commission may please Condone any inadvertent omissions/ errors/ shortcomings in the present Review Petition and may further permit the Review Petitioner to add / modify / change/ amend / alter the present Review Petition and to make further submissions as may be required during the proceedings;

g. The Hon’ble Commission may pass such further & other orders, as the Hon’ble Commission may deem fit & proper keeping in view of the facts and circumstances of the present Review Petition.”
