Subject: Petition of Maharashtra State Power Generation Co. Limited for under Sections 61, 86 & 181 of Electricity Act, 2003 & MERC (Terms and Conditions for Determination of RE Tariff) Regulations, 2010 & Regulation 92 of MERC (conduct of business) Regulations, 2004 seeking the directives of Hon'ble Commission in resolution of dispute between MSPGCL and MSEDCL on Tariff matters for its Solar Power Projects situated at Sakri, Maharashtra.

- **Case No. 128 of 2014**

MSPGCL has submitted a Petition under affidavit on 04.07.2014, under Sections 61, 86 & 181 of Electricity Act, 2003 & MERC (Terms and Conditions for Determination of RE Tariff) Regulations, 2010 & Regulation 92 of MERC (conduct of business) Regulations, 2004 for seeking the directives of Hon'ble Commission in resolution of dispute between MSPGCL and MSEDCL on Tariff matters for its Solar Power Projects situated at Sakri, Maharashtra.

The main prayers of the Petitioner are as under-

“a. Admit this petition for expeditious hearing.

b. Resolve the dispute between MSPGCL and MSEDCL regarding the tariff matters as detailed in the petition

c. Direct MSEDCL to make the payments to make the payments for 89.4 MW at the rate 15.61 Rs/Unit & for 10.6 MW at 11.16 Rs/ Unit to MSPGCL along with arrears with interest.

d. Condone any shortcomings in the petition and allow MSPGCL to submit additional information during the course of proceedings on this petition before this Hon'ble Commission; and

e. Pass such further order(s) as it deems just, fit and proper in the facts and circumstances of the case.”
