MSPGCL, has submitted a Petition under affidavit on 06.05.2014, under Section 94 of EA 2003 & Regulation 85 of MERC (conduct of business) Regulations, 2004 for Review of Order dated 03.03.2014 and corrigendum Order dated 19.03.2014 in Case No. 54 of 2013 on a Petition filed by MSPGCL for Approval of Final True-Up for FY 2011-12, annual performance review for the year FY 2012-13 and Multi Year Tariff for FY 2013-14 To FY 2015-16.

The main prayers of the Petitioner are as under -

*"a) MSPGCL requests Hon'ble Commission to condone the delay in submission of the Review Petition.*

*b) Admit this Review petition.*

*c) Grant an expeditious hearing of this petition.*

*d) Allow MSPGCL to recover the expenses in three equal monthly installments and pass directives to MSEDCL to pay the expenses as approved by the Hon'ble Commission.*

*e) Give necessary clarifications for PAFM computations in case of Koyana HPS and pass necessary directives so that there is no under-recovery of capacity charges for Koyana HPS on accounts of uncontrollable reasons.*

*f) Condone any shortcomings / deficiencies in the petition and allow MSPGCL to submit additional information / data at a later stage as may be required.*

*g) Pass such further order(s) as it deems just, fit and proper in the facts and circumstances of the case."*
