*1. To admit the Review Petition for determination of cross subsidy surcharge accordance with the Section 42(2) and 86(1) of Electricity Act 2003 and Regulation 13 of MERC (Distribution Open Access ) Regulations,2005 and Regulation 85 of MERC (Conduct of Business ) Regulations, 2004;*

*2. To approve the cross subsidy surcharge as worked out by MSEDCL which will be applicable for existing Open Access consumers with effect from 01<sup>st</sup> September 2013 up to 28.02.2014;*

*3. To pass any other order as the Hon’ble Commission may deem fit and appropriate under the circumstances of the case and in the interest of justice.*

*4. To condone any error / omission and to give opportunity to rectify the same.*

*5. To permit MSEDCL to make further submissions, addition and alteration to this petition as may be necessary from time to time”.*
