Subject: Petition of The Tata Power Company Limited for invoking jurisdiction under Section 86 (1) (f) read with 86 (1) (c) of the Electricity Act, 2003 for non compliance by Rinfra-Transmission of this Hon'ble Commission's Order dated 23<sup>rd</sup> August, 2013 in Case No. 120 of 2012.

- **Case No. 110 of 2014**

The Tata Power Company Limited has submitted a Petition under affidavit on 21.05.2014 under Sections 86 (1) (f, c) of Electricity Act 2003 for non compliance by Rinfra-T of this Hon'ble Commission's Order dated 23<sup>rd</sup> August, 2013 in Case No. 120 of 2012.

The main prayers of the Petitioner are as under -

*“a) To direct RInfra to give an undertaking within 7 days that it will provide the Transmission outlets as required by Tata Power – D and sign the connection agreement for outlets within a period not exceeding 3 months..*

*b) Consider the difficulties submitted in this Petition and grant an opportunity to Tata Power to make a representation before the Hon'ble Commission.*

*c) Condone any inadvertent omissions / errors / shortcomings and permit Tata Power- G to add/ change/ modify/ alter this filing and make further submissions as may be required at a future date.*

*(d) Pass any other such directives as that the Hon'ble Commission may deem appropriate in the facts and circumstances of the case.”*

I am directed to communicate that the hearing in the above matter will be held in the presence of the authorized consumer representatives on **Tuesday, 12 August, 2014 at 11.30 hrs** in the office of the Commission at 13<sup>th</sup> floor, Centre No.1, World Trade Centre, Cuffe Parade, Mumbai - 400 005.

4. The Petitioner is directed to immediately serve a copy of its above mentioned Petition (both in soft and hard versions) to the Respondent and the authorised consumer representatives before the scheduled date of hearing.

5. The Respondent is directed to submit its say on affidavit, if any, on the above mentioned Petition with a copy to the Petitioner and the authorised consumer representatives well in advance.
