Subject: Petition of Krishna Valley Power Private Limited for under Sections 42, 86 (c, e), 142 & 146 of E. A. 2003 & Regulations No. 3.1 of MERC (Distribution Open Access) Regulations, 2005 & Regulations 92-94 of MERC (conduct of business) Regulations, 2004 for Refusal of Open Access permission.

- **Case No. 124 of 2014**

Krishna Valley Power Pvt. Ltd. has submitted a Petition under affidavit on 12.06.2014, under Sections 42, 86 (c, e), 142 & 146 of E.A. 2003 & Regulations No. 3.1 of MERC (Distribution Open Access) Regulations, 2005 & Regulations 92 - 94 of MERC (conduct of business) Regulations, 2004 for Refusal of Open Access permission.

The main prayers of the Petitioner are as under-

“a) The petition be allowed.

b) That the Act of the Respondent to refuse Open Access permission to more than one eligible entity be declared as wrong and void.

c) The Respondent be directed to grant open Access permission, in future, to the petitioner to supply electricity to more than one consumer, irrespective of quantum of supply to individual consumer, simultaneously; if they are eligible to receive electricity supply as per Regulations framed by the Hon'ble Commission.

d) All other just and equitable reliefs be granted to the petitioner for the effective adjudication of this case.

e) To condone any error / omission and to give opportunity to rectify the same;

f) To permit petitioner to make further submissions, addition and alteration to this petition as may be necessary from time to time.”
