Subject: Petition of M/s. JSW Energy Limited for application under Petition under Regulations 92 and 94 of MERC (conduct of business) Regulations, 2004 read with Sections 86 (1) (b) and 86 (1) (f) of the Electricity Act, 2003 for certain clarifications and grant of additional time to comply with the Order dated 15.07.2014 in Case No. 118 of 2013.

JSW Energy Limited has submitted a Petition under affidavit on 31.07.2014, under Sections 86 (1) (b & f) of Electricity Act, 2003 & Regulations 92 and 94 of MERC (conduct of business) Regulations, 2004 for certain clarifications and grant of additional time to comply with the Order dated 15.07.2014 in Case No. 118 of 2013.

The main prayers of the Petitioner are as under-

“a) Clarify that the Petitioner may approach the Hon’ble Commission with its facts and justifications for grant of compensatory tariff, based on a mechanism/formula proposed by KPMG in it’s report for the case of the Petitioner;

b) grant additional time to the Petitioner, as deemed appropriate by this Hon’ble Commission, to file appropriate petition/application; and

c) pass such other orders as this Hon’ble Commission may deem just and proper.”
